Applicant must provide a statement from his/her parent/guardian that addresses family support of applicant. The statement can be in English or Spanish, typed or handwritten. Another person may transcribe a statement on behalf of the parent/guardian, if needed. Grammar, writing ability, etc. will not be considered when determining whether a student is selected for NCPA. The statement must speak to the following:

- What do you do to ensure your student performs maximum leadership and academic abilities?
- What would it mean to you for your student to be admitted into NCPA?
- Anything else you think is important for us to know about you and/or your student?

*PERSONAL ESSAY

Essay must be a minimum of one typed page or two handwritten pages. Applicant must provide a personal essay that addresses ALL of the following:

O Why do you want to be in NCPA?	O What does going to college mean to you?
O What goals have you set for yourself?	O How will going to college help you achieve
OAnything else you'd like us to know about you?	your career or life goals?
O Someone who supports you and how?
